**NOTICE REGARDING UNDELIVERABLE AND
NON-NEGOTIATED DISTRIBUTIONS – ACTION REQUIRED**

Please be advised that the Debtors intend to request that the Bankruptcy Court allow the Trustee to modify the Debtors' confirmed plan of reorganization (the "Plan") to permit the Trustee to re-distribute undeliverable or un-cashed payments with respect to: (i) distribution checks or other correspondence that were issued, but were returned as undeliverable and remained unclaimed for at least 180 days and (ii) distribution checks that were issued, but were not negotiated within ninety (90) days of issuance, and remained unclaimed for at least 180 days. Parties are directed to review the Plan for the terms not defined in this Notice.

A listing of the "Un-cashed/Undeliverable" distributions affected by the Trustee's proposed action (the "Listing") is available on-line at www.cfwy.com.

Any holder of an Allowed Claim identified on the Listing must assert its rights pursuant to the Plan to receive its distribution by notifying the Debtors' claims agent, Epiq Systems, Inc. as instructed below, of its current address on or before July 30, 2010. After such date, all Claims identified on the Listing or thereafter identified as Claims for which distributions were either un-cashed or undeliverable shall be discharged and forever barred, and the Debtors shall retain all monies related thereto for the sole purpose of adding such monies to funds in the Trust for purposes of redistribution to other holders of Allowed Claims.

Requests for the re-issuance of any non-negotiated distribution noted on the Listing must be made on or before **July 30, 2010** by calling (877) 647-5873, and providing the Claim/Schedule number for the distribution. Holders of Claims identified on the Listing may send written notice of a current address, to be received by the Debtors on or before July 30, 2010, by e-mail to CFrequest@epiqsystems.com or by mail to Epiq Systems, Inc., P.O. Box 4390, Portland, OR 97208-4390. The written notice must include the Claim/Schedule number, the last four digits of the Claimant's Social Security Number, and the new address for the holder of the Claim.
